The guest confirms to having received and read the Terms and Conditions for staying at the establishment. The guest further confirms that should there not be adhered to these Terms and Conditions, Linquenda, and its employees, reserve the right to enforce for the guest to vacate the premises or to pay a spot fine. This indemnity applies to all persons who enter the Premises, user of any of the facilities on the Premises or participating in any activity on the Premises or arranged by Linquenda (collectively referred to as 'Guests')

The Visitor acknowledges that he/she has read & understands this indemnity & agrees to be bound by the following:

1. I enter and use the Premises, parking areas, surrounds, & participate in any activities at the Premises entirely at my own risk. Children must be under adult supervision at all times.
2. Right of admission is reserved. I agree to obey at all times to any warning notices and instructions of Linquenda.
3. Guests shall not have any claim against Linquenda, and its employees, and shall indemnify them against any claim by any other person or entity, for any loss, damage, bodily injury or death occurring during or in connection with the guest's accommodation booking arising from any act or omission which does not amount to their gross negligence.
4. Point 3 includes any loss of/damage to personal effects/property, any indirect, consequential or special loss/damage, financial loss, illness, injury, harm (as defined in the Community Protection Act (CPA)) or death howsoever caused & legal costs (attorney & own client scale) that Linquenda may incur, unless such claim falls within the ambit of section 61 of the CPA (Act 68/2008).
5. I acknowledge that any assistance that Linquenda may render or arrange is done without any admission or acknowledgement of fault or liability and as a show of empathy & goodwill.
6. Linquenda, and its employees, shall not be responsible or liable, nor issue any refunds, for occurrences resulting in loss of occupancy or personal injury, property loss or damage caused by faults in the electrical or plumbing installations, the breakdown of domestic appliances, invasion of pests, weather conditions, flooding, electricity and water supply disruption and any other circumstance beyond their reasonable control.
7. Linquenda, and its employees, reserve the right to decline accommodation or cancel the balance of the booked accommodation, to any visitor for conduct which in their sole discretion, is inappropriate to the property, or to the comfort of any other visitors. No refund will be payable under such circumstances.
